These interviews would be particularly beneficial for pupils who are undecided as to their post-16 options.

Careers Guidance Interviews

Our knowledgeable and experienced staff can offer face-to-face impartial advice and guidance interviews for Year 11 students on a 1:1 basis, to discuss their post-16 and post-18 option choices, including local and national labour market information and trends. Every pupil will receive a personalised Careers Action Plan, a copy of which will be made available to the School.

Careers Guidance Group Information Sessions

Information, Advice and Guidance can be delivered in groups of up to 4 students, with each student supported to complete a personalised Careers Action Plan.

Group Work Sessions

The aim of the sessions will be to support students to identify appropriate employment, education and training opportunities to move into following Year 11. Possible session topics could include: Re-cap on Post-16 Options, applying for sixth form/ FE, applying for Apprenticeships, understanding the Labour Market and soft skills development. We can also work with the School to design and deliver bespoke sessions, either to students or staff, on any topic you feel would be of benefit to your staff and students.

Attendance at Year 11 Parents/Carers events

We can support with hosting, arranging and facilitating the session and can be available to offer group talks or face-to-face advice for parents on the post-16 and post-18 options for their son or daughter.

Online Careers Guidance and Diagnostic Tools



Connexions Website

Between July 2011 and 1st January 2013 there were a total of 31,157 hits on the Connexions website. This averages out at 1947 hits on the website per month. We can now start looking at how the website is being used and see trends emerging such as peaks in website usage around exam time during June and July.

CV Creator

CV creator is comprehensive piece of software that allows young people to create and manage their CV online. The CV Creator is now available to organisations wishing to offer this online facility to their users. The software includes spell check, email and print functions, and comes with a user guide and administration features that enable you to monitor its usage.

Although we can not define individual users the CV creator section of the website has been used 10,564 times since its inclusion on the website 12 months ago.

Kudos and Careerscape

Kudos is an online careers guidance and information program that supports young people planning their future, suggestions of suitable careers and routes enabling their decision making. Careerscape is the perfect accompaniment to Kudos as young people can access information on subjects, study and training options and qualifications. They can also view details of over 43,000 UCAS higher education courses.

After 12 months of operation a total of 7478 young people have now registered to use Kudos and Careerscape. This is an average of 359 students per school registered to use the system.

NEW FOR 2014- Kudos Inspire

Kudos Inspire is a key element of Inspire, a new approach to raising young people's aspirations and achievement, developed by CASCAiD in partnership with the Inspiring Futures Foundation. In addition to careers matching and information, Kudos Inspire offers extra features that raise the aspirations of 13-19 year olds.


Livechat

Livechat is an online conversational tool that allows young people to come and talk to an advisor in a a "virtual" environment. Feedback has shown that young people really value this method of engagement and it fits in with the way that they now access information.

Since going live in September 2011 we have had a total of 3323 livechat interventions on the system. An intervention is classed as meaningful exchange of information with a specific outcome. These interventions can last anything from 10 minutes to an hour.
